Terms and Conditions Information on how to enter the competition and win the prize, forms part of these Terms and Conditions. Entry into the Primex Field Days Pty Ltd (“Promoter”) Like A Holiday Giveaway (“Promotion”) is deemed acceptance of these Terms and Conditions.
